## BOROUGH OF FOX CHAPEL REQUIREMENTS FOR THE ISSUANCE OF A NO-LIEN LETTER

- No Lien questions should be directed to Dana Abate at 412/850-5020 (dabate@fox-chapel.pa.us).
- A test of the existing sewerage system must be completed and defects corrected or alternate security provided prior to the issuance of a no-lien letter. The homeowner must choose a plumber from the Borough's Plumbers Registration List and have the plumber contact Chuck Smith, Sanitary Sewer Inspector, at the Borough Office (412/850-5030) to make arrangements for the test. The Borough performs the test in conjunction with a plumber retained by the Seller. The Borough charges a \$350 fee (the plumber will have a separate fee) for the test, which must be paid prior to the dye test being scheduled. (Dye Tests are valid for one year *unless* the home is changing owners.) THE PLUMBER SHOULD CONTACT THE BOROUGH OFFICE TO SCHEDULE A DYE TEST AS SOON AS POSSIBLE TO AVOID ANY DELAYS IN OBTAINING A NOLIEN LETTER, ESPECIALLY IF REPAIRS/CORRECTIONS ARE NEEDED. Please see the Borough's website: www.fox-chapel.pa.us for detailed information regarding dye test procedures.
- A Wage Tax Questionnaire Form must be completed by the prospective Purchaser(s) and returned to the Borough Office. If refinancing, the Wage Tax Questionnaire Form must be completed by current Homeowner(s).
- ➤ The Borough charges \$30 for the issuance of a no-lien letter.
