## BOROUGH OF FOX CHAPEL ORDINANCE NO. 702

## AN ORDINANCE OF THE BOROUGH OF FOX CHAPEL AMENDING AND RESTATING THE REGULATIONS FOR PARKING

WHEREAS, Section 16 of Ordinance No. 403, as previously amended, (Chapter XV, Part 1, §16 of the Code of Ordinances) establishes rules and regulations for parking at certain locations in the Borough; and

WHEREAS, Borough Council desires to amend and restate said rules and regulations for parking.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Fox Chapel, Allegheny County, Pennsylvania, and it is hereby ordained and enacted by virtue of the same that Section 16 of Ordinance No. 403, as previously amended, is hereby further amended and restated in its entirety to read as follows effective thirty (30) days following the approval of this Ordinance:

## Section 16. Parking

(a) Parking shall be prohibited at all times at the following locations:

<b>HIGHWAY</b>	SIDE
Ridgedale Lane	Both
Foxtop Drive	Both
Pheasant Drive	Both
Glenhaven Lane	Both
Trillium Lane	Both
Guyasuta Road <sup>1</sup>	Both
Squaw Run Road <sup>2</sup>	East

<sup>&</sup>lt;sup>1</sup> Between Squaw Run Road and a point 500 feet west of Squaw Run Road

<sup>&</sup>lt;sup>2</sup> Between Field Club Road and Hunt Road

(b) Parking shall be permitted at the following designated locations only by vehicles displaying a current permit issued by the Borough:

## DESIGNATED PARKING AREAS

Riding Meadow Beechwood Farms Squaw Run Road Old Mill Road Squaw Run Road East<sup>3</sup>

- (c) The Borough may charge an annual fee, set by resolution of Borough Council from time to time, for permits described in subsection (b) above, and a permit may be revoked with no reimbursement of fee in the event the permit-holder violates this or another Ordinance of the Borough.
- (d) Except while actively engaged in making a delivery to or a pickup from a location in the Borough, unlicensed machines and vehicles and vehicles with commercial licenses may not be parked on any road or street (including right-of-way or easement outside the paved area) in the Borough.
- (e) The Borough Manager is hereby authorized to erect or cause to be erected signs notifying the public of the restrictions imposed by this Section.
- (f) Any person, partnership or corporation violating any provision of this Section shall, upon conviction thereof, be sentenced to pay a fine of not more than one hundred dollars (\$100.00) and costs of prosecution, or in default of payment of such fine and costs, to undergo imprisonment for not more than one (1) day. Each violation of any provision of this Section, and each day the same is continued, shall be deemed a separate offense.
